Columbia County Christian School (CCCS) connected with each student and family during Distance Learning for all to evaluate the successes and struggles as well as the preference of parents and students for the structure of learning for 2020- 2021 school year and intent to send students to school next year. ODE/OHA guidelines have been/will be, read and reviewed by all staff and our school board. In preparation for this school year a task force specifically to address reopening was formed to develop this plan. The task force consisted of the administrator, lead elementary teacher, four board members and Scott Winegar. The operational plan will be communicated through emails to families and community partners as well as posting on the school website.

CCCS is located in Warren, Oregon and serves as the only PreK-8th grade Christian School in Columbia County. We are a small school of typically less than 100 students and have approximately 20-25% of our students on Individual Service Plans or receiving 504 accommodations and modifications.
